# **Matters Arising**

#### 20mph speed limit in Luthrie

Gary Holt advised that Lesley Craig is short staffed and this will take time. He continued by saying that the Scottish government are proposing that the speed limit in all areas where the current limit is 30mph will be reduced to 20mph. This is to be enacted by 2025 but the timescale will probably slip.

#### **Luthrie Noticeboard**

This has been essentially completed with three copies produced. One will be installed in the noticeboard at Luthrie with another being located at the entrance to Norman's Law at Pittachope. After a brief discussion it was agreed that the other should be located at the bench near the "new road" opposite the church.

#### **Luthrie Hall Bench**
