Matters Arising from meeting on February 3, 2016

Andy Heer informed the meeting that a sit visit had taken place at Ballinbreich on the C46 where the alterations to the road were discussed. A timetable has been developed which will see the repairs being completed by the end of 2017.

There has been no repeat of the flooding problems as described.

A Deed of Servitude for Luthrie School has recently been agreed. This will allow the outstanding issue to now be progressed.

The Broadband project has been delayed due to changes in regulations. It is now down to three tenderers and progress should be made by the end of 2017. Jacqueline Montador has recently sent out an update on the project.

Scottish Government Traffic Speed Limit Survey

The Scottish Government has asked all Community Councils to consider their views on blanket 20mph speed limits in built up areas to replace 30mph limits. It was agreed that we did not consider this necessary and the survey would be completed to reflect this view. **Action Bernard O'D.**

Flooding of the road from Luthrie to the A92 at the junction was reported after heavy rainfall. This is a recent development. **Action Andy H.**
