### **Finance**

# **Planning**

No planning applications had been submitted in the period. An appeal had been made by the residents of Carphin regarding a refusal of a retrospective planning application.

# **Request from Luthrie Gardening Group**

The Luthrie Gardening Group requested, in writing, for a grant of £500 to install two benches in the Luthrie garden for the use of local people and walkers. This was discussed at length.

The CC agreed in principle to grant a sum of £200 towards the purchase of benches.

As for the remainder of the application (£300), the local councillor suggested that this could be accessed through Fife Council 'Local Community planning budget'.

## **Roads: Mud**

Jim raised the issue of mud on the road at the entrance to Creich Farm. This is an ongoing problem and the road is never cleaned. It is very dirty for pedestrians and is unsafe for cyclist and motor cyclists. Farmers do have a responsibility to keep public roads clean if they are causing them to be dirty. Andy agreed to discuss this with the local police force.

# **Any Other Business**

### Water at Pittachope Farm

Jim raised the issue here of a blocked ditch causing water to flow onto the road at the entrance to the farm. This was despite significant ditch maintenance having been carried out recently. At a recent cold spell the road was thick with ice as a result of this problem Jim had raised this point with the Council and action had been promised. No action has yet taken place. Bob also reported this at the same time. Andy will raise this issue with Ross Walker in the Council.

## **Complaint regarding access to Core Paths in the area**

Laura raised an issue that has been reported to her by a Luthrie resident who wanted to remain anonymous. The complaint regards the closure of core paths when shooting is taking place together with gates being locked. It also concerns the aggressive nature of the gamekeeper in the area who is also

accused of firing his gun at times to "scare people off". These issues have been raised with the landowner but these issues were dismissed. Bernard will write to the landowner to ascertain the legal position with regards to the closure of the gates and to ask for an explanation for the firing of the gun.
